Your Sales Options Explained

When it comes to selling your Platinum Skies home you have 3 options.

1: Part Exchange

Part Exchange is for those people who have decided to move to another Platinum Skies property, either at the same development or one of our various other locations. This may be because you are wanting to change the size of your property to adapt to your needs, or it may be that you would like to relocate to be nearer friends or family.

Platinum Skies will manage the sale of your property, finding a suitable buyer

either from our customer waiting list or from the open market, and guarantee you a sale at full market value.

When you part exchange all costs involved will be agreed with you, and we can defer those costs until the property you are exchanging has been sold. That way you can move today and pay later.

With part exchange we can get you moved into your new home in just a couple of weeks, as you can move into your new home before the sale of your old home is complete.





Your Sales Options Explained

2: Independently through an Estate Agent

For those confident to manage the sales process and are on hand to support the sale of their property you can, after informing Platinum Skies, appoint your own estate agent and solicitor to manage the sale and you will pay their costs directly. The agreed sale price will be based upon the price your estate agent feels that they can achieve.

As a leasehold property, purchased through shared-ownership there are several steps involved to complete a sale and we have provided a checklist within this document to help explain what is involved in this option. If you do intend to sell your property independently, you'll need to give us notice of up to 8 weeks, as a provider of shared ownership homes we may have a potential buyer.

If you are selling independently there are a number of costs, in addition to the Estate agent and Solicitors fees that you will need to consider.

- RICS Property Valuation £430
- Energy Performance Certificate £80
- Legal Disbursements £300
- Qualification of new buyer £50
- Parking Licence Administration £25
- Consent to assign lease £100
- Compliance Certificate £50
- Notice of Assignment £75
- Deed of Covenant/Licence to Assign £200
- Management Pack £400
- Facilities Inspection £250






